President's Message

Dear Colleagues

I trust this finds you and your families in good health.

Plans for College Science Week in the future:

College Science week has been held on the Gold Coast for thirteen years. Over the past few years members have asked Council about considering a change in location. Consideration is also being given to separating the examinations from the Conference in future. These two activities are massive undertakings in their own right and delivering both back to back is proving more and more difficult. The current hotel, QT Gold Coast provides us with outstanding service and all that we need to conduct the examinations, including a large number of individual hotel rooms with furniture removed. As a conference venue the QT goes to great lengths to meet our needs, but has approached capacity with our higher attendance numbers over recent years. If Science Week grows to greater than 500 delegates, we will need to consider a larger venue; however taking on a venue such as a Convention Centre could expose the College to considerable financial risk. The Gold Coast boasts attractive ocean views and often migrating whales, but members have made comments that they are tiring of the location.

There are arguments either way - if the examinations are separated from the

Conference we risk losing the attendance of examiners and candidates who have already travelled to college examination. Even if we provided complimentary CSW registration, examiners would still need to pay to transport themselves to the CSW venue at a later date as well as taking additional time off work; both of these considerations may be a disincentive. We also lose being able to utilise overseas examiners as valuable science week speakers despite them having been brought over to Australia/NZ to examine. Many chapters utilise speakers who have also acted as examiners. Examination candidates may not return for Science Week after their examinations. However moving the conference to another destination and rotating it annually may provide opportunity for further growth of the conference.

In 2013, our new Examinations Officer will take on the role of administrative examination coordination, with a view to coordinating the examinations in 2014. From 2015 it is proposed that Mrs Elaine Lowe will take a smaller role in the administration of the examinations to be able to concentrate on the planning and delivery of the College Science Week conference.

All options are currently being considered by Council and we value the input of all College members. The College will send a poll out to all members later in the year. If you have interest in providing feedback on this issue please email me or talk to myself, other Councillors or College staff at Science Week.





Departure of CEO

On March 22, I regrettably received notice of Dr Megan Parker's resignation as CEO of the Australian and New Zealand College of Veterinary Scientists, effective Friday 19th April, 2013. The College Council, Board of Examiners and I will endeavour to assist to maintain the smooth running of the College.

Two places on council are up for election this year for which nominations are currently being called. Dr Liz Dill Macky has indicated that she will end her second term on Council in July and not re-stand due to her relocation to the United States later

Ongoing Advances in International Recognition of ANZCVS Qualifications

The international profile of the college and the international currency of our qualifications (Fellowship in particular) are of paramount importance to our members but especially our fellows and current and potential Fellowship candidates. Our approach is that international recognition of ANZCVS qualifications will come as a result of a sound and respected international profile. We have therefore continued to strategically accept a number of invitations to key international meetings to benefit the college and its profile.

Dr Tias Muurlink attended the European College of Veterinary Surgery's examinations in February 2013 as an observer and exchanged valuable information about our respective College's examination processes. The collaborative examination observation is considered to be an excellent way to observe the standard and methodology of the ECVS and ANZCVS examinations.

Also, in February 2013, Dr Annette Litster attended and addressed the Annual Meeting of the American Board of Veterinary Specialties (ABVS) in snowy Schaumburg, Illinois. Again, it was an extremely valuable opportunity to represent the ANZ College at this important forum.

The three parent organisations - The European Board of Veterinary Specialisation (EBVS), the ABVS and the ANZCVS now demonstrate a strong alliance through the International Veterinary Specialty Working Group (IVSWG), sharing ideas and experiences and looking for opportunities for future collaboration and mutual learning.

In April 2013, Councillor Dr Liz Dill Macky will attend and address the European Board of Veterinary Specialities (EBVS) General Assembly in Brussels, Belgium; plus present two sessions at an examiner training workshop for EBVS Colleges explaining some of the recent work and policies of our Board of Examiners' Examination Committee.

Through these activities, momentum continues to grow and there is ongoing evidence of significant and tangible progress being achieved in promoting our College, advancing international relations and progressing the pursuit of international recognition of our qualifications.

The European Board of Veterinary Specialisation (EBVS)

Dr O'Brien, President European Board of Veterinary Specialisation has explained that the EBVS has looked to the ANZCVS as a model and a partner in several regards.

- The International Veterinary Specialty Working Group (IVSWG) is an example, as is the cross-border interaction and collaboration at the individual speciality level.
- Based on the CEO's professional role in the ANZCVS, the EBVS have just hired a CEO for the EBVS.
- Based on the ANZCVS example, the EBVS are implementing at their AGM a training programme for specialist examiners, with now a component on resident supervision being included.
- They are looking to include a scientific component to their AGM in the near future.
- The EBVS Newsletter, now in 5th edition, has been developed with some mirroring of the ANZCVS College Courier.

Current College Statistics



The College currently has a Membership of 2200; 1703 of which are Members, 225 are Fellows, 15 are Honorary Fellows, 43 are Associate Members, and 214 are Life members or Life Fellows. 1705 (78%) reside in Australia, 281 in New Zealand and 214 in other countries.



2013 Examination Candidature

The healthy 2013 examination candidature indicates the strength and relevance of the College examination system.

26 candidates will sit fellowship examinations in 10 subjects this year.

At the membership level, 161 candidates will sit the examinations, including 11 candidates sitting medicine of cats in the UK, 16 candidates sitting supplementary examinations and 134 candidates sitting all components of the examination. Examinations will be held in 14 subjects. To date 30 candidates had withdrawn from the membership examinations.

Board of Examiners

Dr Zoe Lenard stepped off the Board of Examiners in December. We have been gratefully appreciative of Zoe's valuable contribution to the full Board and the Training and Credentials Committee in particular. We valued Zoe's commitment, intelligence, careful consideration and hard work. The selection committee has recently selected Dr Peter Bennett as Zoe's replacement as a new member of the Board of Examiners, and the Training and Credentials Committee specifically. Peter's skills and background put him in a good position to make a valuable contribution to the BoE; especially because of his previous experiences and involvement with both the Fellowship and US Diplomate training, credentialling and examination systems; plus his office-bearer involvement in the Small Animal Medicine and Oncology chapters.

Dr Liz Norman will regrettably retire off the Board of Examiners at July 2013. Liz has made an outstanding contribution through nine years of involvement on the BoE; most recently as Assistant Chief Examiner – Membership and then Assistant Chief Examiner – Examinations. Liz has introduced significant advancements in College policies and processes, and raised the College's professionalism in examination development and delivery. The Board has selected Dr Stephen Atkinson as the replacement for Liz Norman, effective July 2013. Dr Atkinson comes to the board with strong interest and extensive experience in assessment practice; especially innovative new types of assessment modalities and the specific assessment of candidates' abilities to apply their knowledge and demonstrate a higher level of understanding.

College Office

The College Council is carefully reviewing the ongoing needs of the College Office in order to strategically consider all options for the Office leadership moving forward subsequent to the departure of the current CEO. In the short term; the College Manager, Mrs Elaine Lowe assisted by Administration Assistant Ms Sharon Tinsley and new Examinations Officer Ms Robyn Pettigrew, will continue to handle all routine College functions. The College Council and Board of Examiners will endeavour to

assist to maintain the smooth running of the College.

Ms Sharon Tinsley, our administrative assistant, started her fourth year with the College on 23 November 2012 and continues to efficiently, professionally and cheerfully assist Elaine on a permanent part time basis.

The office in February recruited a new replacement Examinations Officer to take over the founding work of Ms Yvette O'Keefe who returned to University teaching. The new Examinations Officer, Ms Robyn Pettigrew, will have progressive management responsibility for the College's examination administration including preparation, delivery and review of the examinations. Robyn will be responsible for administering and managing a large diverse group of people; collating and presenting information, managing communications, and calling and coordinating meetings as required.

Scientific Writing Workshop



On Friday 12 July between 8.30 and 12.30, The Board of Examiners Training and Credentials Committee invite you to join in a Scientific Writing Workshop with College Fellow Dr Shane Raidal and AVJ Scientific Editor Dr Anne Jackson. This workshop will be of special appeal to Fellowship candidates undertaking the publication requirements for Fellowship but all interested Science Week registrants are welcome to attend.

Fellowship Information Session

On Friday July 12 at 7.30am, The Training and Credentials Committee will be conducting a plenary about Advances in Fellowship Training for any Fellowship Candidates or Supervisors (present or potential) who may be interested and have questions of clarification or concerns about Fellowship training that they wish to raise directly with the Board of Examiners.

Specific focus will be placed on the issue of whether or not the College should move to accrediting training institutions rather than individual training programs.

Counselling

Unsuccessful examination candidates will be invited to attend a guidance counselling session (up to 1 hour at no expense) with a fully-briefed clinical psychologist. The guidance session will be available either in person on the date of collection of Australian exam results at the QT Hotel, or via phone or Skype at another time for both Australian and overseas candidates. The aim of this session is to assist unsuccessful candidates to come to terms with their result, debrief and discuss coping strategies and plans to assist with an attempt to re-sit. Please note these sessions are not able to provide examination information such as a breakdown of marks, details of examination performance, or College examination processes; available information of this type may be obtained through contact with the College Office. Unsuccessful candidates collecting results from the QT hotel who wish to attend a face-to-face guidance counselling session that day may book in through the College Science Week registration desk on Friday 12 July. Unsuccessful candidates receiving notification of results via email or mail who wish to attend a phone/Skype guidance counselling session at a later date may book in by phoning the College Office from Friday 12 July on +61 (7) 34232016.

Fellow Subscription Form

College Fellows are requested to complete the self-evaluation tick-box form accompanied to their annual subscription renewal. Supportive documentation is not required. Through the form, Fellows will be able to demonstrate a range of activities undertaken in a professional capacity. This self-evaluation scheme will have a number of benefits:

- It will permit the Collect to collect data regarding the CPD activities of Fellows
- It will remind Fellows at subscription time that there is an expectation they should be able to demonstrate a high level of CPD involvement and thus competence in their discipline
- It will demonstrate to regulatory bodies that the College views the Fellowship qualification as a measure of excellence and that Fellows are expected to work at this level

At this time this information will only be collected; and will permit the College to identify or flag any perceived areas of concern in the future to ensure that the Fellowship qualification continues to represent a measure of specialist-level skills, knowledge and excellence.



Meeting between Councillors and Representatives of Chapters about a proposed Examination development Fund

A meeting was held on 20 February, 2013 between Councillors and representatives of Council to explain the requirement for a sustainable continuous development system for College examinations and to flag Council suggestions on how this strategic objective might be resourced.

The Board of Examiners and Council have determined that there is a need to establish an examination development fund to support examiner training and examination development projects. At the meeting some very draft concepts were flagged with Chapters about how to establish the required fund. The meeting was intended as a means of delivering some thoughts to stimulate discussion with and between chapters. Council will work on a proposal and on the Thursday morning of Science Week there will be a formal face-to-face meeting between Chapters and Council where Council will deliver the formal proposal to Chapters.

The ANZ College is in the process of rapid growth and development and recognises its important role and its place as a benchmark organisation internationally. The examination QA processes are continually being refined to improve the robust nature of the examination system. Some of the ANZ College's processes are so highly regarded they are being duplicated by overseas Colleges. The current Board of Examiners is passionate about examiner training and the seeking of external consultation for assistance with ongoing improvements to the

exam system; for the benefit of the examination candidates and the broader profession.

The examination system has traditionally been desired to be self-funding but this is no longer possible. The current ANZCVS exam fees in no way offset the costs involved in developing and delivering the examinations to candidates. The exam system is losing money and needs to be supported by funds from the general account (general membership of the College) to break even. Despite economies of scale with a bumper examination cohort in 2012 and 2013, the examination system is anticipated to lost nearly \$11 000 this College financial year. So there is no room for diverting funds generated from examinations into examination development initiatives such as examiner training, external consultants, analysis, software development for data management etc. A fund is planned to be established for this purpose, to allow the examination system to continue to improve in efficiency and quality.

Chapter Meeting at Science Week

A follow up meeting with Chapters and members of Council is scheduled for Thursday 11 July, at 6.30 a.m. at the College Science Week Venue. Chapter representatives are invited to come along and discuss the examination development fund plus other matters of interest and concern with Council and hear about latest Council initiatives. Breakfast will be served.

Exam writing workshop

An inaugural exam writing workshop was held on Saturday-Sunday, 2- 3 February 2013, at Rydges Hotel Southbank, Brisbane. The Chief Examiner, Dr Mandy Burrows; Assistant Chief Examiner- Examinations, Dr Liz Norman; and two additional members of the Examination Committee, Drs Sharanne Raidal and Carolyn Guy; were in attendance throughout the workshop as facilitators. Professor Glen Coleman attended as the external expert/facilitator. The President, Dr Philip Moses; The Chief Examiner – Elect, Dr Mark Owen and the CEO, Dr Megan Parker were also in attendance throughout - to support the delivery of the workshop. Exam writing attendees were representative examiners and CEC liaisons for a selected pilot group from Small Animal Surgery Fellowship and Membership, Small Animal Medicine Fellowship and Membership, Veterinary Emergency and Critical Care Membership and Medicine of Cats Membership examinations. In addition one of the examiners for Veterinary Radiology Membership was able to participate on the second day. The program included blueprinting against learning objectives, exam writing – setting the questions and grading criteria and quality assurance and proof reading. Feedback from the workshop was overwhelmingly positive with nearly all respondents being grateful for the opportunity to attend and indicating that the workshop assisted with the construction of the examination. Respondents especially liked the dedicated time face-to-face with another examiner plus the Chapter Examination Committee (CEC) liaison in their subject to plan the exam as a whole and write the exam questions; applying greater consistency to questions. Being together helped with mark allocation and refined ambiguity, redundancies and errors and allowed 'real time' testing of the questions and appropriate pitching of the degree of difficulty. The instant face-to-face format was found to allow better version control and to be much more

time efficient than email or Skype to resolve matters especially for examiners in different time zones etc. It was found that feedback from all stakeholders was immediate, saving a lot of time to-ing and froing. More work could get done in a shorter time frame. Assistance from the examination committee and the external consultant; and contact with the other examiner and CEC in the subject were all highly beneficial. Suggestions and explanations in the presentations especially in relation to blueprinting/writing/standards were helpful. It was commented that the weekend promoted a sense of Collegiality/feeling valued and involvement in the College exam process.

It is proposed that this examiner training be continued to include a greater breadth of Membership and fellowship examiners. It is felt that if we desire a robust strong and quality examination product, then the College and the Chapters have to invest in training examiners. Options for examiner training (just one intended recipient project of the proposed examination development fund) include brief face-to-face two-day exam writing workshops, on-line learning and modular delivery.

ASSOCIATE MEMBERSHIP

1.1 Definition

Associate Members will be restricted to veterinarians who:

- reside in Australia or New Zealand
- have successfully completed UK, European or US Diplomate examinations¹
- are likely to contribute to the College;
- are proposed and seconded by Members of the College;
- pay the College's annual subscription fee.

1.2 Implementation

1.2.1 Applications for Associate Membership shall be made to the Council in writing from qualified veterinarians who reside in Australia or New Zealand and shall include the following:

- documentary evidence of place of residence
- documentary evidence of successful completion of UK, European or US Diplomate examinations;
- an outline of how the applicant has or will contribute to the College;
- a proposer and seconder, both of whom must be Members;
- payment of the College's annual subscription fee.

1.2.2 Applicants will be notified within 14 days following the next scheduled Council meeting at which their application is considered.

1.2.3 Associate Members will be required to pay annual membership subscriptions. They are allowed full voting rights and the ability to stand for Council and other positions of office, and will be entitled to use the letters MACVSc after their name.
